Exhibitors will be permitted into the open (non-reserved) grooming space at 11:30 am. Exhibitors without reserved grooming space will not be permitted to drive into the building. Vehicles will be directed to the loading ramps beginning at 11:30 am. The line will form from the loading dock doors along the north curb of westbound Reno. No vehicles will be allowed in the line from eastbound Reno.

The west bound lane of Reno nearest the building (far north lane) will be closed every morning at 8:30 am to facilitate drop off and move in. Once that lane has closed you may park and unload or load from the street.

We ask that you be patient and we will try to make every effort to get you in and out as quickly as possible. DO NOT leave your dogs outside unattended without proper ventilation.

All Grooming will be allowed to move out the west doors on Sunday ONLY!

An up-to-date map with the latest information on road construction around the Cox Center will be sent out with the Judging Program

UNLOADING/LOADING PROCEDURES

RESERVED GROOMING ONLY ** PLEASE READ **

Exhibitors who have reserved grooming spaces will be allowed to drive into the building at 7:00 am on Tuesday, June 18th, 2013. Your vehicle must be out of the building by 10:00 am. If you are planning to drive into the building, you must form a line along the north curb of westbound Reno until directed into the Plaza by an Event Official. You will not be allowed to form the line before 7:00 am due to traffic consideration. This will be enforced by the Oklahoma City Police Department. Once inside the building, you will be directed to your grooming area. Please unload & remove your vehicle from the building as soon as possible. You will exit the building through the west exit onto Robinson. Event Officials may ask you to remove your vehicle from the building to allow more exhibitors into the building in the allotted time. When your vehicle is in the building, keys must remain in the vehicle & the flashers must remain on. By entering the building in a vehicle, you grant permission to an Event Official to move your vehicle should the need arise. The number of vehicles allowed inside the building at one time will be determined by Event Officials & you may be directed to wait in line until there is adequate room for you to safely operate a vehicle inside the building. Please follow all direction given to you by Event Officials during the loading/unloading procedures.

All vehicles must be removed by 10:00 am. The building will be opened 30 minutes after Best in Show Sunday, June 23rd, 2013 to allow vehicles to drive in & load equipment. The number of vehicles allowed in will be limited due to safety considerations. All vehicles must be removed from the building by 7:00 pm Sunday, June 23rd, 2013.

Anyone after drive in times will need to dolly in.

Please leave your key in your vehicle & emergency flashers on at all times while you are unloading or loading.

If you are driving into the building, please have your proof of insurance available. We ask that you be patient & we will try to make every effort to get you in & out as quickly as possible.

DO NOT leave your dogs outside unattended without proper ventilation. All grooming will be allowed to move out the west doors on Sunday ONLY!

ATTENTION EXHIBITORS

SEE UNLOADING/LOADING PROCEDURES FOR RESERVED GROOMING ABOVE

Conformation building will be available for Vendors at 6:00 am, for Reserved Grooming between 7:00 am & 10:00 am and Open Grooming at 11:30 am on Tuesday, June 18th, 2013. All dogs must be removed from the buildings immediately following Best in Show judging on Sunday, June 23, 2013.

The building will be locked from 11:00 pm to 6:00 am each day.

FLASHERS MUST BE LEFT ON AT ALL TIMES WHILE UNLOADING.

All dogs present must be on leash or confined to their crates except when being judged or when in the exercising ring.

Dogs, while on exhibit in the show building or show ring, may be photographed or videotaped by spectators. Only the Show Photographer will be allowed inside rings.

THE CLUBS RESERVE THE RIGHT TO SUBSTITUTE A PRIZE OF EQUAL OR GREATER VALUE. No Carpet, Plastic Sheeting or Mats are allowed in grooming areas.

To insure adequate space for grooming and quartering of dogs, the Clubs will require exhibitors to stack crates and to comply with any limitations as may be imposed by the Superintendent or Event Committee - Cluster Committee.

Parents are responsible for children at these shows.

THERE WILL BE NO CRATES OR TABLES ALLOWED WHATSOEVER IN THE CONFORMATION JUDGING AREAS, UNLESS PERMITTED BY SHOW COMMITTEE.

Ready rings will be by each conformation ring, we ask you to use these areas to keep main aisles clear.

NO SOFT-SIDED CRATES ALLOWED RINGSIDE, OR IN THE OPEN GROOMING AREAS. ALL CRATES MUST BE STACKABLE.

NO unentered dogs allowed at these shows.

Grooming area set-up is under the supervision of the BUILDING AND GROUNDS COMMITTEE who may require rearrangement of exhibitor set-ups where space is not properly used.

OPEN GROOMING will be available at 11:30 am Tuesday, June 18, 2013. Any items placed in the open grooming area prior to 11:30 am may be removed by the Show Committee. There will be no drive-in available for open grooming. Open grooming in the building is limited to designated areas & is available on a first-come, first-served basis.

NO EXERCISE PENS IN OPEN GROOMING.

Crated dogs will be allowed in building overnight at owner/agent's risk. Neither the Show Superintendent nor Kennel Clubs will be responsible for any dogs or equipment. Each Crate containing a dog in the building overnight must have a tag attached to it with the name, location & phone number of the person responsible for that dog.

There will be on-site dog bathing facilities & expanded public exercise pens.

Exhibitors are responsible for cleaning their grooming area. The Show Committees will tour the grooming area after Groups each day & messy areas will be tagged. Continued grooming area violations can result in your grooming area privileges being suspended.

The Show Committee reserves the right to require the stacking of crates, limiting the use of exercise pens & grooming tables & any other remedies it may deem necessary for space & the safety of all in non-reserved & reserved spaces on a case by case basis at their committee's discretion.

The safety & welfare of all dogs is the sole responsibility of the exhibitor. It is the sole responsibility of the exhibitor that no dogs are left unattended on grooming tables.

The Show Committees reserve the right to remove exercise pens anywhere in or around the building if not maintained. Private exercise pens are allowed in the reserved grooming area only. Any sawdust or paper used in exercise pens must remain clean & odor free. Should soiled pens become an issue, the Show Committee will remove the offending pen & revoke the privilege for a private exercise pen.

All sawdust & material used in reserved grooming areas **MUST BE REMOVED** before exhibitors depart the building on Sunday, Violators will be assessed a fine that must be paid before grooming spaces may be reserved for next years show.

Public exercise pens will be provided & dogs must be attended by owner or handler while in use.

GENERAL RULES

No smoking permitted in the building.

No extension cords may cross aisles.

No rugs, plastic sheeting or mats will be allowed in the building.

Disruptive behavior on the show site will not be tolerated at any time.

Proof of rabies vaccination of any animal at or on the show grounds is required.

Any battery powered vehicles must be approved in advance by the Show Committee to be used in the building. ADA approved devices will be allowed at all times. The Show Committee will use due care & diligence for the welfare of dogs & exhibitors but will not be responsible for, or assume any liability in the event of an accident or misfortune, to either dogs or exhibitors participating in these shows.

Where feasible, rings will have holding areas for temporary crating & portable tables. NO PLASTIC is allowed under or around x-pens.

Booth Exhibitors are subject to all restrictions in this premium list.

No flyers, handbills or other information may be distributed or posted without written permission of the Classic.

NO BABY STROLLERS ALLOWED.

No gasoline or diesel generators are permitted inside the building.

RV parking provided one block from show building. See page 26 for details.

Unloading will be off of Reno Street ONLY.

Loading and unloading, grooming areas and parking will be controlled by the grounds committee. Per Fire Marshall, no plastic will be allowed under or around x-pens.

MEDIA

Videotaping by individuals for their own personal use will be allowed outside show rings only. The show committees reserve the right to regulate placement of cameras to prevent interference with traffic flow and exhibiting of dogs.

LIABILITY

Management, show-giving clubs or their subcontract labor are not responsible for the loss of, damage to, or death of any dog exhibited, or the possessions of any participant, whether the result of accident or any other cause. It is expressly understood that every dog at this show is in the care, custody & control of its owner or handler during the entire time the dog is on the show premises.

By entering this show, all owners, handlers, breeders & kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to the Oklahoma City Kennel Club, Inc., the Mid-Del-Tinker Kennel Club, Inc., the Lawton Dog Fanciers Association, Inc. and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeders and kennels participating in the show shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL

MONEY ORDERS IN U.S. FUNDS.

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Superintendents will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging rings.

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Superintendent is not able to cash checks.

RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Superintendent will add a fee for completing the transaction and/or

reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Superintendent.

The show giving Club, the Show Superintendent, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form. Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$3.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.00 will be charged for all cancellations or changes made prior to closing of entries. **EXHIBITORS NOTE:** Please notify Superintendent of any change of address.
