The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 24 hours, please call the Trial Secretary by telephone.

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.
- Entry fees will not be refunded in the eventthat a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Entries must be made on Official AKC Entry Forms or copies and <u>must include the signed</u> <u>Agreement and Rules</u>. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries.


If there is a tie the dog with the most points for the crossdrive wins, followed by the dog with the most points for the outrun, lift, fetch.
