Breeder's Showcase Rules

- Each entry shall consist of 3 dogs. They may be any combination of male and female. Each dog must be a minimum of 6 months of age at the time of show.
- The entry will be judged against the breed standard, and consistency within the group.
- Each dog must be entered elsewhere, in any sweeps, non-regular or regular class.
- Each entry shall have at least one breeder in common. The name of this breeder must be exactly the same but may fall in any order on the registration.
- An entry may be handled in the ring by anyone, i.e., breeder, owner or handler. If the breeder is not able to show themselves, they must be ringside for a valid entry.
- Each breeder may only be represented by one entry.
- All entries must be registered in accordance with AKC rules for entering an AKC sanctioned show.
