## **Generations Class Rules**

- Each entry shall consist of 3 dogs. All dogs must be related, and consecutive generations. (Example: grandmother, mother, daughter) They may be any combination of male and female. Each dog must be a minimum of 6 months of age at the time of show. They will be judged against the Breed Standard, for consistency within the group
- Each dog must be entered elsewhere, in any sweeps, non-regular or regular class.
- An entry may be handled in the ring by anyone, i.e., breeder, owner or handler. If the breeder is not able to show themselves, they must be ringside for a valid entry.
- Each breeder may only be represented by one entry.
- All entries must be registered in accordance with AKC rules for entering an AKC sanctioned show.
