Double Q Ribbons and New Title Rosettes will also be available for those earning those honors.

Rosettes and “MACH Bars” will be awarded for those earning a MACH title Rosettes and “PACH Bars” will be awarded for those earning their PACH title

Special Awards Rules

- Regular/Preferred/A Class/B Class will compete for same level awards
- Only Qualifying Runs will count.

The formula for calculating High in Levels will be:

- Novice – 6 points for each qualifying run (All Standard, All JWW, and FAST)
- Open – 7 points for each qualifying run (All Standard, All JWW, and FAST)
- Excellent – 8 points for each qualifying run (All Standard, All JWW, and FAST)
- Master – 9 points for each qualifying run (All Standard, All JWW, and FAST)

The formula for calculating Overall High Scoring Dog and Preferred High Scoring Dog will be:

Highest Total Points, calculated from the actual score received plus any bonus points listed above for high in Levels. If there is a tie, then the YPS will be calculated using all 4 runs, Trial 1 and Trial 2 (Std and JWW) (No YPS for FAST)

Junior High in Trial Award

Will be calculated the same as Overall High scoring dog.

The Formula for calculating the Overall High scoring Dog from the Fast Class:

All levels combined. Bonus points will be awarded to calculate this as follows.

Novice

Novice Raw score, Open – 5 Bonus Points, Excellent and Masters will receive 10 bonus points. All Bonus points will be added to the number of points scored in the Fast Class. If there is a tie, total time will be used. Example: Open dog scores 74 points, plus 5 bonus points for a total of 79. Master dog has a score of 68 plus 10 bonus points, for a total of 78. Then the overall score of 79 will win the award.

The Formula for Premier Standard and Premier Jumpers HIGH in Trial:

The total time of both runs will be added together to determine the winners. Fastest combined time wins.

The Formula for Time 2 Beat High in Trial

The total time of both runs will be added together to determine the winner. Fastest combined time wins.

Notice to Exhibitors

- Email, telephone, fax, and unsigned entries or entries without fees cannot be accepted.
- Entries not on Official AKC Agility Entry without the Agreement and Rules attached to the Official AKC Entry will NOT be accepted.
- Express Mail Entries must include signature permitting them to be left at the Secretary's address without recipient's signature.
- Returned or postdated checks do not constitute a valid entry fee.
There will be a \$30 service charge for each returned check.
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Owners are responsible for errors in making out entry forms correctly and no entry fees will be refunded in the event of such errors or cancellations of entries after the published closing date.
- Miniature American Shepherd Club of the United States of America (MASCUSA) may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against MASCUSA or any official thereof.
- MASCUSA will not be responsible for any lost or damaged items left at the show.
- The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Puppies under the age of 4 months are strictly prohibited from the premises.
- Unentered dogs and bitches in season will not be permitted on the premises.
- Entry fee will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of judge or show committee.
- Bitches in season will not be admitted to the Trial. Entry fee (minus \$15) will be refunded for bitches in heat. Notification must be received 30 minutes before the start of judging.
- Canadian Exhibitors must make fees payable in US funds. MASCUSA assumes no responsibility for cash sent through the mail.
- Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any entry fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by
reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area
- Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials.
- Please clean up after your dog. Receptacles will be provided.
- Overpayments of fees less than \$10 will be considered a donation to the club and will not be returned.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

MOVE-UP REGULATIONS: Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is made in writing to the trial secretary only. Pretrial moveups (for either day) must be received by the trial secretary by 6:00 p.m. Monday, October 3, 2022

Day to day move-ups are offered and must be received by the trial secretary in writing at the trial site by the end of ribbon awards on Monday, October 12, 2022

Dogs moved up will be entered at the end of the running order, and every effort will be made to accommodate handlers running multiple dogs in the same class. *A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class.*

Fix and Go On

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

HEIGHT DIVISIONS: Owners are responsible for entering the proper height divisions. Handlers may opt to run in a higher height division in the Regular program, but not in a lower division than their proper height division. Handlers must run in their proper height division in the Preferred program.

Dogs that run in a height division lower than their proper division will be eliminated.

It is your responsibility to have your dog measured if he does not have a height card. If you need to be measured at the trial, please check the "My dog needs to be measured" box on the entry form.

DOGS ELIGIBLE TO ENTER: All dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Mixed breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form.

SAFETY: The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

COURSE FAMILIARIZATION/OBSTACLES: Handlers are permitted to walk the course, without a dog, prior to the start of the class. A walk-through period will be held prior to each class. The walk-through may be split at the judges discretion. The judges briefing will outline the course and answer handler questions. Obstacles will meet the specifications for obstacles in the current edition of the regulations for Agility Trials. There will be no contact familiarization for Novice dogs at any of these trials.

ELECTRONIC TIMERS: This trial will be using electronic timers in all rings.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lesser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners** SM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
