# ATTENTION EXHIBITORS

The Show Site will be available to exhibitors at **4:00 pm Wednesday, September 16, 2015.** Dogs and all equipment must be removed from the show site immediately following Best in Show judging Sunday, September 20, 2015.

# **PARKING**

Exhibitor and visitor parking will be located on blacktop parking lots in front of Purina Event Center. Vehicles are limited to **ONE PARKING SPACE.** No ex-pens or crates allowed on blacktop, but are allowed on grass areas. No cones allowed in parking areas. **NO PARKING IN ROADWAYS** or next to building. THE GATEWAY CLUSTER parking committee will be in charge of all parking for this event.

# **RV PARKING**

There are seventy-six parking spaces located behind the Purina Event Center. Each space has 50 and 30 amp electric, with water and sewer hookup. An additional 48 parking spaces with 30 amp electric and water for filling tanks are available on the gravel lots located above the outdoor show site. The fee for RV parking is \$25.00 per night (see RV parking application on page 13). The lower RV lot will be used only after the upper lot is sold out. There will be no RV parking on any blacktop lot. No reguest for specific parking space can be honored. The GATEWAY CLUSTER parking committee will be in charge of all parking for this event.

# **GROOMING & CRATING**

Grooming and crating in designated areas only. Grooming in the Purina Event Center will be 5 x 10 foot spaces. The fee for grooming with electricity is \$30.00 for the entire event (see grooming space application on page 14). Reservations will be accepted until Wednesday. September 2. 2015 at 12:00 noon. There is a limit of four (4) spaces per person. There will be limited free grooming spaces available with no electric, again with a limit of four (4) spaces per person. THERE WILL BE NO ELECTRIC CORDS ALLOWED IN FREE GROOMING AREA. Anyone found with dryers or electric cords in free grooming will face an event committee & will be removed from the building. The Purina Event Čenter will be available at 4:00 pm on Wednesday, September 16, 2015. Do not arrive before 4:00 pm - there will be no lines allowed outside the doors prior to the opening of the building. Bathing of dogs is restricted to bathing area of the building - no dogs allowed in restrooms. The Purina Event Center will close & doors will be locked at 10:00 pm & will re-open at 6:00 am. Guards will be on duty. Dogs may be left inside the building on Thursday, Friday & Saturday nights only. No cones, baby strollers, ex-pens, cocker pens or puppy pens allowed inside the building at any time. Additional free grooming with electric is available down the hill beside the outdoor show site. Please stack your crates and limit the number of grooming tables. All vehicles must leave their headlights on while loading & unloading in the designated loading/unloading areas which are clearly marked. No vehicles may park in roadways to unload.

# **FOOD CONCESSIONS**

The Purina Checkerboard Cafe, located close to the Great Hall & Gateway Hall, provides a wide selection of food options. Purina prohibits exhibitors bringing their own food or beverages into the Event Center.

# **EXHIBITORS & GUESTS**

No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance". These are separate divisions of Purina and are not part of the show grounds. No dogs allowed on the second floor of the Purina Event Center. There will be no baby strollers, cones or firearms allowed in the Purina Center.

(American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 1st Entry & \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3) These Fees are paid to the American Kennel Club.

CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.

There will be no refund for duplicate entries.

Dogs need be present only for scheduled judging and will be released if not needed for further judging.

Dogs allowed in rings during judging only.

Dogs must be ready for judging. Neither the club nor its Show Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.** 

The Club reserves the right to substitute a prize of equal or greater value.

All trophies must be claimed the day of the show - None will be mailed.

All checks issued as prizes are the sole responsibility of the recipient. Lost, stolen and/or misplaced checks will not be replaced. Checks are valid for 90 days. The Show Secretary is not able to cash checks.

**RETURNED CHECKS/DECLINED CREDIT/DEBIT CARDS** do not constitute a valid entry fee. Fees must be paid in guaranteed funds. Checks will not be accepted. The Show Secretary will add a fee for completing the transaction and/or reprocessing the entries. Repeated occurrences from the same exhibitors may result in their being put on a CASH ONLY basis.

Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Show Secretary.

The show giving Club, the Show Secretary, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.

Changes, additions or corrections to entry forms must be received in writing prior to close of entries. Those received by telephone are not acceptable.

Refunds of \$3.00 & less will not be issued due to the costs of processing.

An administrative fee of \$2.00 will be charged for all cancellations or changes made prior to closing of entries.





# Beginner Puppies (4-6 months of age) AKC Sanctioned Beginner Puppy Competition!

# **Section 1- Classifications**

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

# Section 2 - Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered
- AKC registration number or an AKC litter number will be required for all entries.
- A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay. Dogs may not be exhibited by current assistants and household members of a professional handler.

Entry Fee: \$20.00 (including AKC recording fee of \$2.00 for each dog. These fees are paid to the American Kennel Club.)

Entries will close Wednesday Noon, September 2, 2015 at Superintendent's office.

# **AKC NATIONAL OWNER-HANDLED SERIES**

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.



"DON'T FORGET TO CHECK THE OWNER-HANDLED BOX ON THE ENTRY FORM IF ENTERING THIS COMPETITION."



All dogs that are owner-handled and are not solely owned or exhibited by professional handlers\* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner\*. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

**STUD DOG CLASS** - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but MUST be entered in the Stud Dog Class, the Get MUST be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

**BROOD BITCH CLASS** - Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**BRACE CLASS** - Two dogs of the same Breed or Variety of Breed with one or more common owner and both dogs must be entered in another class.

# **BEST BRED-BY-EXHIBITOR RULES**

Best Bred-by-Exhibitor will be conducted following Best of Breed and Owner Handler judging. An eligible Bred-by-Exhibitor dog must be handled throughout the show by any person who is a breeder of record and an owner or co-owner as of the date of the show. To be considered eligible, the dog's entry must indicate that the dog will be eligible to compete on the day of the show. If the dog is not able to be eligible on the day of show, it may be withdrawn from the Best Bred-by-Exhibitor competition. All dogs in the BOB competition (including WD and WB) that are eligible will compete for Best Bred-by-Exhibitor. The ring steward will ask for only those eligible dogs to stay in the ring. If no dog from the BOB competition is eligible, then the the ring steward will ask the Reserve Winners Dog and Reserve Winners Bitch, if eligible, to return to the ring to compete. If neither of those are eligible, then the winners of the Bred-by-Exhibitor dog and Bred-by-Exhibitor dots.

- The following categories of dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs
  which, according to their owner's records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show
  where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. - Mixed Breed dogs entering classes for Agility, Obedience and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All-American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
